4. Presentations

a. 2015 Audited Financial Statement

John Bujold, Collins Barrow SGB LLP, presented the Audit Report for the 2015 financial statements. It is the opinion of Collins Barrow staff that the financial activities of SVCA are in accordance with the Canadian generally accepted accounting principles (GAAP) and that the financial statements present fairly, in all material respects, the financial position as at December 31, 2015. In the opinion of Collins Barrow staff, SVCA is in a positive financial position as it has adequate cash and net financial assets to meet its current obligations with no debt. Mr. Bujold thanked SVCA staff involved in the audit for their assistance and cooperation in completing the audit. The General Manager/Secretary-Treasurer thanked Mr. Bujold for executing the audit in an efficient manner.

b. <u>Gay Lea Foods Co-Operative Ltd.</u>

Chair Luke Charbonneau introduced Darren Ireland, Plant Manager, Gay Lea Foods Co-Operative Ltd. Mr. Ireland provided a PowerPoint presentation in which he explained that Gay Lea is a company that is concerned with the economic viability of the community and in his opinion, the town of Teeswater would continue with a substantial decrease in population, and that many of the town's amenities would be slated for future closure should the expansion plan of Gay Lea Foods be declined. He presented his views regarding the company's current and possible future plant expansion plans. Mr. Ireland raised concerns including the use of old flood plain mapping and the relevance of the Hurricane Hazel flood standard. Mr. Ireland acknowledged that a permit application has not been submitted for the contemplated work. The members thanked Mr. Ireland for his presentation and resolved to work with Gay Lea Foods to settle the issues as presented.

5. Matters arising from the Minutes

a. Bluffs Campground Business/Marketing Plan

Shannon Wood gave a presentation on the Saugeen Bluffs Business/Marketing Plan and advised the Authority of several updates. Jim Penner has begun marking of 8.5km of trails for use by campers with horses. The event ring already has six events scheduled. It was suggested that rather than purchasing a honey wagon, local companies may be able to bid on sewage disposal and quotes are currently being collected. Wi-fi will be set up at the gatehouse, store and the Sutherland Centre. A donation of games tables for the Sutherland Centre's new games room has been made. Three 'bunkies' have been ordered from a local business at a cost of \$1400 each. The Authority members expressed their excitement regarding the Business/Marketing plan and thanked SVCA staff for their efforts and enthusiasm. Shannon was asked to provide an electronic copy of the full Business/Marketing plan to Authority Members.

Stewart Halliday left the meeting at 2:50pm.

b. Chatsworth Rd Issue

The GM/S-T reviewed the issues surrounding the Municipality of Chatsworth request to transfer an approximately 3.4 acre parcel of SVCA land for the purposes of solving a road visibility and safety matter. The Authority discussed the possibility of setting a precedent in the donation of land but it was pointed out that a complicating factor involved an encroachment of part of the road on SVCA property. After discussion, the Authority members made the following motion:

a. Huron Kinloss: SVCA/MVCA

Wilf Gamble presented a letter addressed to Eleanor McMahon, MPP, requesting that the Township of Huron Kinloss transfer its SVCA jurisdiction to the MVCA since it is currently split 57% to 43%. He believes that there is difficulty in implementing Source Water protection under both Authorities which have differing policies. The GM/S-T noted that there is nothing in the current Conservation Act that would allow for a change of governing Authority. It was noted that only five of the Member Municipalities have SVCA as its sole Authority.

c. Gilmor vs NVCA update

The GM/S-T informed the Authority that NVCA has been granted leave to appeal the court decision. MNRF will be providing \$15,000 to fund the appeal and will seek leave to intervene. As well, the Ministry of the Attorney General is requesting leave to intervene and Conservation Ontario is seeking leave to be granted intervenor status.

d. News Articles

The GM/S-T submitted articles from local newspapers regarding the SVCA for the purpose of keeping the Authority members up to date on current events. There were no questions related to the news articles.

10. For the Good of the Committee Reports

- a. A news article on the front page of The Post, March 31, 2016, regarding the Maple Syrup Festival is good publicity for SVCF.
- b. It was noted that several Members had received reports of safety issues regarding dogs running at large on SVCA lands. It was discussed that this could be a major issue especially at the Bluffs as horses and dogs don't mix. An idea was brought forward to look into off-leash areas for dogs. The Chair would like this matter referred to the Parks committee.
- c. Concern was raised due to the lack of policies regarding the presentations of delegations at Authority meetings.
